

Achievements


- Licensing framework for digital broadcasting is in place
- **THREE** Signal Distributors/ Multiplex Operators has been licensed since 2010;
- **TWO** Signal Distributors/Multiplex Operators have started to roll out, one with 7 digital transmitter sites and another 4 sites;
- Legislations:(EPOCA, 2010) addressing digital migration issues has been assented while draft regulations are in the final stage to be signed by the Minister;





Achievements..

- Monthly meetings between the NTC-DB and Signal Distributors to discuss challenges and problems on the migration process;
- A quarterly steering committee meetings composed by Permanent secretaries from 6 Ministries
- The President of the United Republic of Tanzania officially launched the public awareness campaign for digital migration on 24th August, 2011 and its LOGO.








DTT market in Tanzania

Television Population Coverage






DTT Market in Tanzania

Challenges






Challenges

- Pricing of digital television transmission services
- Interoperability of Digital receivers
- Migration cost/ dual illumination
- Foreign content dominating multiplex capacity
 - Most are satellite foreign content rebroadcasted in DTT platform
 - The ratio of one third of multiplex capacity to be FTA has not yet been achieved
 - This defeats the purpose of the regulator of promoting production of local content and results on foreign content to dominate DTT platform
- Infrastructure sharing

Convergence of technologies..

- No boundaries between telecommunication and broadcasting networks (Convergence of technology);
- No distinction between telecom and broadcast receivers.
- Content may be available on broadcasting or telecommunication networks
- Convergence of devices and services

Regulatory Frameworks

- The need for sufficient funding for the Public broadcaster
- Joint effort for addressing the issue of STBs interoperability
- The need for legislations/regulations on infrastructure sharing for enforcement purpose

- Voluntary registration of new media services
